

NEW FEATURES IN THIS RELEASE

MULTI-FACTOR AUTHENTICATION

This release includes the new multi-factor authentication feature which allows users to receive a one time passcode at their notification email address in order to log into the Direct platform. Using this feature adds an additional layer of security to the logon mechanism of the platform. Please note however that if the notification email is not accessible then it will not be possible to sing into the platform should this feature be enabled.

XDR MDN CONFIGURATION

It is now possible to configure the MDN for XDR related messages upon request to DataMotion support. Configuration options for this include the addressBlock and message Disposition sections of the MDN. This feature has resolved Ticket#10192330.

NPI numbers not being found.	An update to the NPI registry URL was required for using the API to search. This has been completed and the issue resolved.	Resolves Ticket# 10190051
