## **NEW FEATURES IN THIS RELEASE**

#### CLINICAL MESSAGE DELIVERY

This release includes support for the Clinical Message Delivery application.

#### **SFTP**

Secure File Transfer Protocol has been implemented as a transmission mechanism as of this release.

#### ENHANCED FEATURES IN THIS RELEASE

#### PERFORMANCE IMPROVEMENTS

Improvements to the overall performance of the HISP and Direct Messaging system have been made to handle additional message volume.

#### TOTAL VIEW REPORT IMPROVEMENTS

The Total View Report has been enhanced to include a Message ID field for XDR type messages.

#### INBOX AND TRACK SENT PAGES IMPROVEMENTS

The Inbox view page and the Track Sent view page have been enhanced to include a time stamp column. Please note that the time stamp itself is included as part of the Date column.

#### MESSAGE TRACKING REPORT IMPROVEMENTS

The Message Tracking Report has been enhanced to return results more quickly.

#### **SOAP ENHANCEMENT**

The cmv4 SOAP API has been enhanced to support higher attachment size.

#### IN-REPLY-TO HEADER CHANGE

The In-Reply-To SMTP header slot will now contain the original message ID.

## **RESOLVED ISSUES**

The following-reported issues have been resolved in this release.

Table 1. Resolved Issues

Description	Resolution	Notes
The C-CDA Delivery Service was creating duplicate attachments.	In some cases the C-CDA Delivery Service was creating duplicate attachments when processing payloads. This has been corrected.	Only affects C- CDA Delivery Service customers.
There was an issue receiving from DIRECT.BHMCNY.ORG domain.	There was an issue receiving some messages from the DIRECT.BHMCNY.ORG domain. This has been fixed.	Resolves ticket#10200594.
There was an issue parsing messages with special characters.	Certain special characters were causing issues when parsing a message. This has been fixed.	Resolves ticket#10195402.
There was a Delivery Status Notification issue with XDR type messages.	Sometimes a Delivery Status Notification would not be delievered if a XDR type message failed. This has been fixed.	Only affects customers using XDR.
